Further, SeaVentures cannot be held responsible for inconveniences, including the ability or suitability to scuba dive, losses or additional expenses due to hotel, or airline irregularities, sickness, weather, labor disputes, quarantine, government actions or other factors and causes beyond our control or the control of the supplier. SeaVentures reserves the right as deemed necessary and without notice, to cancel, modify, or substitute on any tour, schedules, rates or use of affiliated companies.

**Rates** All rates are per person, double occupancy, unless stated otherwise. Single occupancy accommodations are available upon request at a surcharge. All rates are subject to change without notice.

**Rate Changes the** SeaVentures reserves the right to change the price of any package at any time. In the event of a major increase in price, client shall have right to cancel with refund.

**Deposits** **Deposits are required to confirm reservations and are nonrefundable.** Full payment is due \_\_\_\_\_ days prior to arrival. Holiday periods and live-aboards may have different deposits and full payment policies. Reservations made within 30 days of departure are subject to a \$25.00 per person fee for long distance phone calls and document delivery charges, telexes, Federal Express, and airport drop-off charges. Scheduled payments and final payments received late may be subject to an additional charge to cover additional costs.

**Cancellations/Refunds** **Cancellations made within the balance due period are subject to loss of all money paid.** There are no refunds or credits for unused services/portions of packages due to customer choice, weather, or circumstances beyond the control of the supplier. **Passports/Visas/Tourist Cards** It is the participant's responsibility to have the proper travel documents. Costs incurred for incorrect entry documents (i.e. cancellation or delays) will be the responsibility of the participants. SeaVentures will be glad to advise of proper documents needed.

**Minors** Participants under 18 years of age traveling to some countries with one parent (regardless of marital status) must carry the following:  
1) A notarized letter from the non-accompanying parent stating their knowledge and permission for the child to travel to that country.  
2) A notarized copy of a deceased parent's death certificate.

Minors traveling without either parent must contact the appropriate consular office to ensure proper documentation. Minors denied boarding or entry into a country due to improper documentation will receive no refund.

**Airfare** All airfares are subject to change until paid for and ticketed. Airfares used in certain packages may have certain restrictions. Deviations or changes in air itinerary may result in additional charges.

**Baggage** Economy class passengers are allowed 2 suitcases and/or dive bags on flights within the U.S. and to and from the U.S. The combined length, width and height of both bags may not exceed 106 inches, and either bag may not exceed 62 inches of combined dimensions. **On other flights,** 44 pounds maximum free baggage is allowed. The Civil Aeronautics Board requires that all luggage have outside name tags.

**Airport Departure Taxes** Most countries have airport departure taxes which cannot be prepaid.  
**Changes** Any changes made to reservations will be subject to a change fee to be determined by the extent and timing of the change and any charges imposed by supplier. Minimum charge shall be \$25.00 per person/per change.

**Groups** The required deposit is due within 7 days of booking to avoid possible cancellation. Unless otherwise indicated in writing, final payment is required 60 days prior to departure. Late payments are subject to additional charges to cover additional costs. Any payments made within 30 days of departure must be in negotiable funds.
